

Section - 2 DETAILS OF PROGRAMME/PROJECTS

Livelihood, Sustainable Agriculture & Poverty Alleviation Programme

Building and Strengthening Farmers Organizations

With the objective to strengthen farmers and to



organize them into groups a farmers club was formed with support from NABARD at Ghiajodi village of Saraskana block. It is the informal forum of the

village. After the formation of the club a Base Level Orientation Training (BLOT) was organized to train the members of the club and other farmers for to imparting information and providing them knowledge on various Agriculture Schemes, Bank credit facilities and horticulture schemes.

Besides, the organization has 5 no. of farmers club

are under its own management in Kuliana and Barasahi block. We have planned to form around 20 more farmers club in the next financial year to



make avail more and more benefit to the farmers and will initiate all agriculture development programmes through these farmers club. For the sustainability of these club a token membership fees and monthly savings that decided by the members have been collected by them and are kept in their bank account.

The formation of Farmers' Club lead to better Banker-Borrower relationship in the area. It increase in deposits, increase in the credit flow and diversification of lending, generates new business are most importantly stands for the Socio

constantly monitoring the club to widespread their activities. Recently the club members are engaged to prepare a Village Credit Data to ensure the availability of crop loan to all BPL farmers.

<u>Bio-Organic Farming Promotion</u> (<u>Programme on Vermicompost and</u> Organic Manure)

Organic agriculture is one among the broad spectrum of production methods that are supportive of the environment. Organic production systems are based on specific and precise standards of production which aim at achieving agro-ecosystems which are socially and ecologically sustainable.

Organic agriculture is based on minimizing the use of external inputs, avoiding the use of synthetic fertilizers and pesticides. And it goes beyond the application of certain technologies and requires a particular mind set or attitude on behalf of the producers.

Sakti Sikha in its major activity, to sustain agriculture & to conserve soil environment has implemented an Programme on the Promotion of Vermicompost and Organic Manure. The project was supported by NCSTC, Dept. of Science & Technology. Govt. of India. The main target group of this project was the Farmers, Women SHGs, Teacher & Students.

A series of activities was organized among the target groups to advocate and capacity building on Organic agriculture, Vermicomposting, soil health, pollution, fertility, erosion & conservation of soil and optimum utilization of Bio fertilizers. Due to excessive use of synthetic and chemical fertilizer the land become less fertile and productivity hampers at large, so also food security is in danger. Therefore this project has a tremendous impact on the agro family so also agro-



The activities included-

Lecture-cum-Demonstration

Demonstration programmes were organized in various schools to educate and aware the students & teachers on solid waste management through



Vermicompost & the usage of various organic manure like crop residues, cow dung, bio degradable waste, etc. The participated students were advocated the effects of organic farming in maintaining the soil fertility, upgrading the soil quality and improves its

structure. They were make aware about the benefits of organic farming and how it improves the soil to be managed for better production with nutrition preservation and good



health through demonstration (power point presentation). Total **5 programmes** were conducted in five High Schools of Mayurbhanj district covering **613 students & 47 teachers**.

Competition - Student activities are lead to multi tier



quiz programmes on the related issues to local problems and technology available for finding solutions. This activity is specifically meant for school students. Essay

writing, & Debates competitions were organized on the theme – Role of Organic Farming in Mitigation of Climate Change. Total 5 programmes were conducted

in five schools of Mayurbhanj covering **120 participants**. During the programme, debates on Promotion of Organic Farming, Soil erosion, Tree plantation.



Meet the Expert – With the help of experts drawn from local



laboratories/universities, discussion were organized to create awareness about intricacies involved in actions by community to reduce the impact and so

on. To give an exposure to the students and to provide them a platform to



specialist total of **4 programmes** were organized in four schools of Mayurbhanj covering **659 students**.

Discussion in Presence of Expert – In presence of the Experts, a session of discussions was take place in schools. It helps the students to be able to put forward their views and find solutions of the doubts related the issue.

Total **4 discussions** were conducted in four schools of Mayurbhanj covering **562 students**. During the

programme, discussion was held on the adoption of effective soil management practices which include adoption of Organic Farming technology, Tree



plantation. This programme has a tremendous effect on the knowledge level of the students. With the help of the present resource persons the participants were able to know why organic farming and its preservation are important.

Training for Teachers – A training programme was organised to develop resource persons and prepare materials for organizing training at state level. It aims



at Inculcation scientific temperaments and environmental awareness among the Tribal & Rural masses. The training includes the benefits of organic farming, establishment and

management of Vermicompost unit, managing the unit for sustainable productions, marketing and packaging. Training was also imparted on cultivation

of Bio-fertilizer species, intercropping, mixed cropping and post harvest preservation through Bioagents. Total 54 science & geography teachers were attend the programme.



Integrated Farming and Livelihood Development

Dairy and Poultry plays a very important role in rural poverty alleviation, especially for the socio-economic empowerment of the small and marginal farming families. These activities if properly managed can promote the the living conditions of the poor farming and non-farming families. This also leads to women



SAKTI SIKHA in its tools for reduction of rural poverty, implementing a pilot programme for the promotion of hybrid poultry and dairy farming among the rural poor. The entry level programme was started in Giajodi, Tentoli, Kumbhari, Mundhbani and Murunia village of Saraskana Block of Mayurbhanj district and Kenduadia, Nuagan, Jagatipur village of Balasore district.

In the initial stage of the project training programme



was organised in the said villages on the promotion of Hybrid (Banraj) poultry farming and Diary development. About 290 beneficiaries both from farmers and SHG members

have given training on breed selection, vaccination, managing animal health, fodder cultivation, credit and market linkage.

After the training around 85 beneficiaries were selected for dairy promotion. In collaboration with **NABARD**, Sakti Sikha plans to facilitate credit linkage for all these 85 farmers for at least 2 hybrid cows to

each family for sustaining their livelihood. We are also planning to establish a Milk Cooperative at Jharpokharia to provide marketing support to around 200 milk farmers.



Along with this about 210 BPL women from 28 SHGs were selected for the promotion of Hybrid Poultry farming. Each member is to provide minimum 20 chiks. We are supporting them with chiks, poultry management training and market linkage.

Programme on Soil Management

Massive use of synthetic fertilizer and pesticides damage the soil structure and also adversely affect the soil fertility. Loss of soil fertility hampers the production system and farmers are getting very less return in turns of their investment and labour. Sakti Sikha in its major activity, to sustain agriculture, conserve soil environment and managing food security implemented a project on Soil Management. The project is sponsored by NCSTC, Dept. of Science & Technology, Govt. of India.

The main target group of this project was the Farmers and Women SHGs.

A series of activities was organized among the target

soil and optimum utilization of Bio fertilizers amongst farmers and SHG members the stress was on Soil Management. In Mayurbhanj 80% of the soil is acidic in nature. So it is very important for the farmers to understand the nature & characteristics of soil and manage it for sustainable agricultural development.

Rural Food Security Programme

Sakti Sikha (SS) has sought to address the high food insecurity among the marginal and landless farmers through innovative efforts by encourage home garden, livestock keeping and grain bank systems. SS provides for strengthening linkages between the farmer community and the government. It promotes grain banks, horticultural practices, organic and community farming.

Vegetation and Livestock Promotion: Home garden were promoted in Dumar and Rangamatia village of

Jamda block of Mayurbhanj district. 49 poor SC/ST family were provided with vegetable kit to manage their own home vegetable garden.



Livestock were also introduces to them for additive nutrition and food supplements.

Improved Grain Storage: Grain store training helps rural communities alter their traditional grain stores



and reduce the current average losses, which exceed 40% from field to table. Training the local community on improved grain storage techniques and tools allows

them to reduce the field-to-table losses. Grain storage trainings were conducted in Sankhunta, Sahadagadi and Titia village of Gopabandhu nagar block of Mayurbhanj district covering about 296 farming family. Food security for youth and child is ensured through this initiative.

Food Drying Training: Typical on-farm losses from field to table exceed 50% due to the lack of food preservation knowledge and methods. These trainings include alternative low-cost drying structures, education about appropriate drying methods, and information sessions on how to reconstitute the dried foods for preparation and use in cooking.



Through MGNREGS scheme the government aims to

remove poverty by assuring at least 100 days employment to one adult from every household. To ensure people that are aware of the scheme,



SAKTI SIKHA conducted various orientation programmes. Gram Panchayats and Gram Sabhas have been assigned a critical role in the implementation of the scheme and have been given the mandate of ensuring that the benefits reach all sections of the community.

SAKTI SIKHA is assigned by the DRDA, Mayurbhanj to



conduct Social Audit of all the work implemented during 2010-11 the year under MGNREGS in Saraskana block Mayurbhanj district of Orissa.

We have conducted the Audit in 15 GP of this block along with the Block level Administrative Officials.



We have adopted 53

points of audit process for ensuring transparency & accountability in MGNREGS.

Vocational Training / Entrepreneurship Development of SC & ST Youth

ST and SC are the most marginalized section of the society, therefore to assist their socio-economic development; there is an imperative need to provide more employment avenues and income generation opportunities.

Sakti Sikha's initiatives to address this issues aimed at

upgrading the skills of the tribal youths in various traditional/modern vocations depending upon their educational qualification, present economic trends and



gain suitable employment or enable them to become self employed.

Training was provided to the 51 tribal youth on Floriculture and Vermicomposting. Duration of the



training was 3 months. The tribal unemployed and less educated youth benefited from this training and are encouraged for self employment. The

effectiveness and creativity of the tribal youth are developed through training, demonstration exposure on methods such as landscaping, choosing of brand and breed for flower, land preparation and use of organic fertilizers, water management, establishment of Vermicompost unit, managing and marketing, etc.

We are also in the process of linking them with credit institutions and marketing agencies.

Support to SC/ST Farmers for Increase **Production of Pulses & Oilseed**

Pulses among the major cash crop have been

cultivated by the farmers of Mayurbhanj and Balasore. The farmers of this region produce Mung, Biri and Arahar as the major pulses Ground nut and and



Sunflower as the main oilseed. Now Government has increased the minimum support price (MSP) of these crops so that if the poor farmers will give much stress on these cash crop and increase their land use under the cultivable are definitely they will get more income.

SAKTI SIKHA undertake its activity in accordance with



the NFSM and supports the poor SC/ST farmers by providing them with Biofertilizer, Vermicompost, seeds, fertilizers Micronutrients free of cost

which has give boost to the productivity, balance the agro eco-system, and will increase the income of the poor families. This project directly benefits the poor farming family by ameliorating their economic stability.

This year 16 farmers were provided with support by means of agro inputs of Barasahi block of Mayurbhanj



and constant monitoring was also done to ensure benefit for the farmers.

SRI (Systems of Rice Intensification) methods of Paddy Cultivation

Rice is the main crop cultivated in India. The farmers of our working region are cultivating rice three times a year where irrigation facilities are available. They are practicing the traditional methods of cultivation using the synthetic fertilizer and harmful pesticides, resulting gradual decrease in production and less income with huge investment.

SRI, the system of rice intensification is a system of production of rice. SRI is considered to be a disembodied

technological break through in paddy cultivation. SRI involves the application of certain management practices, which together provide

better



growing conditions for rice plants, particularly in the root zone, than those for plants grown under traditional practices. This system seems to be promising to overcome the shortage of water in irrigated rice. It has proved that if properly followed SRI will increase the production of rice upto 30% extra with less investment in water, labour and fertilizer. Very importantly it is a process of eco friendly and climate resilience agriculture system.

Sakti Sikha is constantly working on the Climate Resilience Agriculture Technology. Under its initiative around 75 farmers of Kuliana and 36 farmers of Barasahi block were given training on SRI methods and our expert group were constantly monitor the



field activity of beneficiary farmers from field preparation to post harvest process. With our initiative the beneficiary farmers have get 36% extra production. Therefore the

project put a tremendous impact on the surrounding villages and people are much interested in the new system of paddy cultivation.



Environment & Climate Change Programme

Community Action for Bio-diversity Conservation

SAKTI SIKHA under the flagship programme of NATIONAL ENVIRONMENT AWARENESS CAMPAIGN 2010-11 has organised workshop on "Agro Biodiversity Management for Eco Friendly Agriculture".

The programme was funded bv the **Ministry** of **Environment** and Forest, Government of India.



The workshop advocated the effects

of Climate Change on Agriculture and suggest measures for reducing the effect. Focus was on the practice of Organic farming activities with specific emphasis on Green Technology, Use of bio-fertilizer and bio-pesticides, mixed cropping/inter cropping, Systems of Rice Intensification (SRI) methods for sustainable rice production and Vermicomposting as well.

Small and Marginal Farmers, members of women SHGs were the primary stake holders. Farmers were

advised to practice bio farming systems for sustainable production and Food Security. ensure SHGs Women were recommended to take up



bio-fertiliser and Vermicompost as an economic activities. Managing Agro bio-diversity will leads further to soil and water conservation and will reduce chemicalization of agriculture and food grains.

SAKTI SIKHA works towards raising awareness on climate change and CDM through organizing issue based events, workshop, policy dialogues and field based plantation. The awareness drive were implemented in a efforts to combat global warming & green house effect.

Water Management & Conservation

Safe & Portable drinking water for all is a major challenge before the community of our working area,



SAKTI SIKHA sincerely initiates its efforts towards water management as it is a vital input for the development of agriculture, industry and service

sectors so also the mankind itself. In its activities to ensure access to safe and adequate drinking water and sanitation are key to the well being of our people. Drinking water



is one of the key components of development programme for building efficient, modern rural infrastructure.

Awareness drive, capacity development activities were initiated by SAKTI SIKHA among the rural community for the effective use of water & managing water to ensure water for all. The women were making aware on the following measure to manage water in effective way — For kitchen particularly, careless wastage of water should be stopped and they should be made aware of its value. So they should not use water more than what is actually required. Modern cooking systems like use of pressure cookers can save more than 25% of water.

In house water is mostly, used for cleaning utensils, wiping floors, washing clothes, etc. So water should be judiciously used.

Instead of throwing the stored water (as people have tendency to store fresh water daily) can be used for washed, gardening or for cleaning.

Agro Bio-diversity Conservation Programme

Climate Change is adversely and seriously affect the agriculture system and its productivity. Due to irregular rainfall, high temperature agro eco system become dis-balance and resulting high food insecurity, crop losses and less production.

Sakti Sikha under its prior activities working on conservation of agro bio-diversity and promoting agroforestry, because agroforestry is one of the major tool for



minimizing the climate change affect on agriculture. It aware the farmers and community on the issue and causes and promote agro-forestry in some villages of Mayurbhanj and Balasore district.

Community Health Action

HIV/AIDS Prevention Programme

SAKTI SIKHA actively involve in HIV/AIDS, Malaria and TB from the inception and creating awareness, capacity building, out reach campaign, medical aid camps and distribution of mosquito net, condoms in collaboration District Health Department and Lepra Society.

The seriousness of HIV/AIDs can be well judged by the

increasing number of the affected people in rural areas. Migrant labors, who go to the other places often get contaminated by their visits



to the red light areas and when they go back home, they pass on the disease unknowingly to their wives. Condoms are sadly still little used by most of these people as they consider it a barrier to the sexual pleasure. Lack of sensitivity seems to be the major reason for this default, leading to disease. Since migration is rampant in our working area and looking this issue in front village level sensitization drives were organised to maximizing public knowledge that since there is no cure for HIV/AIDs, prevention and prevention alone is the cure. Safe Motherhood & Child Health

The campaign rally was covered Baripada town and on major spot of the town human chain has been created to attracting public opinion.

Education & Development

Adult Education and Skill Development

Education has been responsible for brining about changes in all walks of life, and the process continues.

This education must be practical and well adapted to their needs. This programme gives the priority to the education of adult women. It aims at making women more



conscious of their rights and responsibilities and to achieve economic viability and also importance of their socio - economic development.

Mayurbhanj is predominantly a tribal dominated district of Orissa. In this district the situation of women literacy is too precarious. Our organisation organised programmes on Women Literacy & Skill Development to strengthen the under privileged women of G B Nagar Block both in educationally & economically. Along with literacy programme short term training programme on Phenyl making was conducted which will help the women to make their own home enterprises and ultimately help for their

economic independency. Total 5 literacy camp are organised covering 169 BPL women.

Women Development through SHG Promotion & Microfinance

Women Development is among the highest priority area of SAKTI SIKHA. Since its inception Sakti Sikha is constantly working for the upliftment of the down trodden women. It sincerely follows its efforts towards women empowerment & development. Promotion of SHG, microfinance & organising the women group into entrepreneurs is a major activity of Sakti Sikha.

Self-help groups (SHGs) are formed for the economic and social empowerment of tribal women. The groups provide the women with alternative income sources; enhance their sense of dignity; and raise their social status by increasing their participation in the process of local self-governance. Tribal women are encouraged to organize into groups and develop the habit of saving to prevent them from being exploited by unscrupulous money-lenders.

SHG groups and federations are also encouraged to address social issues including construction of village roads, prohibition of alcohol; monitoring the management of primary schools; the functioning of public distribution systems; and access to non timber forest produce.

In this year 6 new women SHG were formed with 65 SC/ST women. Including this now SAKTI SIKHA is mobilising 79 SHGs for income generation and promote their living conditions.

A sum of 30,000/- were distributed among the newly formed 6 groups of Rs. 5,000/- each group as a seed money for starting their own income generating programmes. These groups were provided training on nursery raising & Bio-fertilizer production followed by capacity building on fund mobilisation, group bonding and entrepreneurship management.
